### INSTRUCTIONS TO CANDIDATES FOR THE SCREENING TEST

1. Kindly print and carry **two copies** of this admit card along with the attached **original passport-sized photographs** and report to the examination center (**one copy of this admit card must be submitted to the invigilator**).
2. The **reporting time** at the examination center is **10:30 a.m.** No entry will be permitted after **11:45 a.m.**
3. Please bring your **original photo identity card** (Aadhar Card, PAN Card, Voter ID, Government Bank Passbook with photograph, Bar Council Identity Card with Photograph, Permanent Driving License, Passport, etc.) issued by the government. Please note that a **Ration Card** and **Learner's Driving License** will **not be accepted** as valid ID proof for this purpose.
4. Your **name on your photo ID proof** should match the **name printed on this admit card**. In case you have **changed your name**, you must **produce the original Gazette notification, Marriage Certificate, or Affidavit**. Furthermore, the **photograph attached to this admit card** should match your **government-issued photo ID proof**.
5. Please bring a **ballpoint pen (blue or black ink)**. The use of **pencil, ink, or gel pens is not allowed**.
6. Please **fill in** your required particulars, including your **seat number** and the **name of the question paper set** correctly, along with your **signature on the OMR sheet** using a ballpoint pen (blue/black) in the appropriate boxes. A **second OMR sheet will not be supplied** in case of any mistakes made by you in any circumstances.
7. Please **sign two copies** of the admit card and put your **left-hand thumb impression** in the **presence of the invigilator** in the examination hall.
8. Before **leaving the examination hall**, please ensure that your **admit card and OMR sheet** are **signed by the invigilator**. One copy of the admit card must be submitted to the invigilator, and retain the other copy of the admit card until the scrutiny process is finalized.
9. Entry into the examination center with mobile phones, tablets, laptops, smartwatches, or any other electronic gadgets is strictly **prohibited**. Possession of incriminating materials, electronic gadgets/devices, or any other aiding material in the examination hall will be considered a serious offence and will attract **immediate cancellation** of candidature as well as further recruitment processes.
10. The entire examination will be conducted under **CCTV surveillance** and recorded by video camera. Impersonation will lead to immediate **disqualification from the examination** as well as further recruitment processes.
11. **You will not be permitted to leave the examination hall before the conclusion of the screening test**. Ensure that the OMR sheet and one copy of the admit card are handed over to the invigilator before leaving the examination hall at the end of the screening test.
