- (i) Consistently Good Academic record in Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the Grading System is followed) in a concerned/relevant/allied subject from a recognized Indian University, or an equivalent degree from an accredited foreign university.
- (ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph. D. #### GENERAL INSTRUCTIONS, ESSENTIAL INFORMATION AND CLARIFICATIONS:

- 1. Only hard copies of Application with required enclosures will be accepted. Applicants must send **five** hard copies of the application on or before **10/04/2024** till **5:30 p.m.** alongwith all self-attested testimonials, certificates and all supporting documents related to Academic Performance Indicators (API) wherever required or else the application will not be considered. Applicants must produce original testimonials, certificates and other documents at the time of interview, if called.
- 2. The candidates must possess the required qualifications as on last date fixed for receipt of applications in the notification by the University i.e. 10/04/2024.
- 3. Candidates for the post of Professors and Associate Professors must fill-in and attach Academic Performance Indicator (API) based, Performance Based Appraisal System (PBAS) alongwith the print out of Application form, failing which the applications will be summarily be rejected.
- 4. Experience and qualification will be reckoned as on last date for submission of applications. No updating of qualification and experience will be entertained after the last date.
- 5. Applicants are advised to submit the applications to the University well in advance without waiting for the last date to avoid postal delay or any delay due to other unforeseen events or circumstances. The University will not be responsible for any postal delay at any stage.

- 22. Candidates applying for the post(s) reserved for SEBC should submit a self- attested copy of valid caste certificate specifically mentioning Creamy Layer-exclusion in the format prescribed by Govt. of Gujarat.
- 23. EWS vacancies are tentative and subject to further directives of GoG and outcome of any litigation. The appointment is provisional and it is subject to the Income and Asset certificate being verified through proper channel and if the verification reveals that the claim to belong to EWS is fake/false, the services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provision of the Indian Penal Code (IPC) for production of fake/false certificate.
- 24. The qualifications and other conditions prescribed in the present advertisement are subject to the regulations/norms stipulated by the UGC/NCTE other relevant apex bodies from time to time.
- 25. Under the term 'good academic record' the candidates must have obtained at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's degree level, or an equivalent degree from an Indian/Foreign University.
- 26. The prescribed qualifications and experience are minimum and the mere fact that a candidate possesses the same will not entitle him/her for being called for interview.
- 27. The University reserves the right to restrict the candidates to be called for interview to a reasonable number on the basis of qualifications and experience higher than the minimum prescribed as decided by duly constituted Screening Committee(s) and approved by the competent authority. - 31. Incomplete application in any respect will not be considered.
- 32. Notwithstanding anything contained herein, the University reserves the right to:

  - (b) Draw reserve panel(s) against the possible vacancies in the future

- 50. Incase of any dispute/ambiguity that may occur in the process of selection, the decision of the Vice-Chancellor, K.S.K.V. Kachchh University in all matter relating to eligibility, acceptance or rejection of applications, mode of selection, conduct of examination/interview will be final and no query or correspondence will be entertained in this connection from any individual or his/ her agency.
- 51. Fake/Derecognised Institutions: Candidates, who have obtained degrees or diplomas or

certificates for various courses from any Institution declared fake/derecognised by the University Grants Commission, New Delhi shall not be eligible for being considered for recruitment to the posts advertised.

- 52. The applications received shall be screened as per screening guidelines published in UGC Regulations, 2018.
- 53.
