KSKV Kachchh University Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree Ordinance, 2016 Ordinance – 158.7 (Amendment)

O.158.7 Allocation of Research Supervisor: Eligibility criteria to be a Research Supervisor, Co- Supervisor, Number of M.Phil./Ph.D. scholars permissible per Supervisor, etc.

Modification in O.158.7 (1 &2), is as under. It Shall come into force from 02/08/2021.

1. In the faculties of Arts, Science, Commerce, Education, Law, Management, Rural Studies, Computer Science and Information Technology and Homeopathy of K.S.K.V. Kachchh University the recognition of a teacher of a university department/ an affiliated college/ an affiliated recognized institution as a Research Supervisor for the degree of Ph.D. shall require the fulfillment of the following eligibility criteria:
 - (a) One must be a full time, regular teacher of a university department/ an affiliated college/ a recognized institution, confirmed in his / her position / service.
 - (b) A full time, regular Professor in a university department, with at least five research publications in a referred journal / peer reviewed or care listed journal published after the completion of his / her Ph.D. programme; and an Associate Professor in a university department / a Principal in a college/ an Associate Professor in a college with at least two research publications in a referred journal / peer reviewed or care listed journal shall be recognized as Research Supervisors for the degree of Ph.D. by virtue of his / her said designations without being subjected to any formal process of scrutiny and recognition.
 - (c) A full time, regular Assistant Professor, confirmed in his / her position / service, in a university department / an affiliated college / an affiliated recognized institution, with at least two research publications in a referred journal / peer reviewed or care listed journal shall be eligible for applying to become a research supervisor for the degree of Ph.D and he/she shall be recognized as a research supervisor for the degree of Ph.D.
2. A co-research supervisor may be permitted in a Ph.D. programme in interdisciplinary research areas from a university department / an affiliated college/ an affiliated recognized institution of K.S.K.V. Kachchh University or a university department / a college/ a recognized institution of a university other than K.S.K.V. Kachchh University, subject to the approval of the Research Advisory Committee of the concerned subject and Board of University Teaching.
3. All the formal requirements for a research supervisor for the degree of Ph.D shall be in accordance with the rules and regulations of University Grants Commission (U.G.C), Medical Council of India (M.C.I), National Medical Commission (NMC), All India Council for Technical Education (A.I.C.T.E), Central Council of Homeopathy (C.C.H.) and other such regulatory bodies for a given subject.
