3. The University has the right to accept a tender in whole or part or to reject it without giving any reason.
4. The rate should be inclusive of all taxes, excise duty, GST and other charges such as FOR University, Forwarding, Octroi, Customs, Insurance, Clearing etc. and the supply should be to the store of the Department.
5. Demand draft of Rs.20,000/- in favor of the Registrar, KSKV Kachchh University, Bhuj, should be given as an earnest money deposit along with the tender.
